DEPOSIT: All booths are required to submit a SEPARATE \$50 deposit (check is OK for *deposit only*) to insure you attend and do not leave before 4PM.

***Sanger Chamber Members can deduct \$10.00 from their space fee total providing you have a Sanger Business License AND a current Sanger Chamber Membership.**

Attention FOOD Booths: Plus remember to enclose a separate check for **\$47.00** for Health Department inspections, made payable to the Sanger Chamber. PLEASE READ the Fresno County Food Booth requirements. There are NO refunds if you do not meet the requirements. Some of the new rules are: 1) Full booth enclosure by at least 16 mesh per inch screens 2) 3-compartment sinks required for utensil washing 3) Potable and waste water tanks (Chamber will supply waste water disposal tank) 4) Operator supplied sanitizer test strips required to check sanitizer levels. 5) Hand washing units required prior to set up. See a list on their web site: www.fresnohumanservices.org then go to Community Health and then to Environmental Health tab for a complete list of the new rules and regulations.

- We recommend that you bring some type of weather protection for your booth as the weather is unpredictable at this time of the year and there are NO refunds for bad weather. Please return the entry form as soon as possible.
- **You need to supply your own electricity, tables, chairs, etc. NO Parking spaces are available by your spaces so please You will need to UNHITCH your trailer from your vehicle.**

bring a dolly to help restock your booths during the day.

All booths where food is being cooked and/or where you use a generator, barbeque, propane cylinders, lanterns, any open flame, electrical, or any other heat source must have a minimum of a commercial grade 5 lb. 2A-10BC fire extinguisher that has either been purchased or serviced within the past year. You must show that it has been serviced or purchased within the past year by providing a receipt or inspection tag with the extinguisher.

All electrical must be heavy-duty cords with an electrical ground.

All cooking appliances must be UL approved and listed appliances and must be inspected.

Portable LPG fuel tanks shall be located outside enclosed booths. Generators shall be located a safe distance away from the booth. DO NOT STORE GAS CONTAINERS NEXT TO THE GENERATOR.

- The SEPARATE \$50 deposit check will be returned provided you come on time, follow the rules, and do not leave BEFORE 5PM.
